Vaccines for Children (VFC) Program Federal Funds	Children 0 through 18 years of age who qualify for VFC	<i>All</i> Advisory Committee on Immunization Practice (ACIP) recommended vaccines
Utah CHIP	Children 0 through 18 years of age insured through Utah's Children's Health Insurance Program (CHIP)	<i>All</i> ACIP recommended vaccines
State Funds	Children 0 through 18 years of age with commercial health insurance with no vaccine coverage (underinsured), presenting at participating local health departments <sup>3</sup>	<i>All</i> vaccines required upon entry into a Utah school for the first time

<sup>i</sup> VFC eligible children may not be refused publicly funded vaccine for the inability of the parent/guardian to pay the administration fee. Individuals cannot be sent to a collection agency for failure to pay the administration fee of a publicly funded vaccine.

<sup>ii</sup> Children are considered underinsured for vaccines not covered by the health insurance plan. Children whose insurance plans have deductibles and/or co-pays are considered insured and do not meet the criteria for underinsured. Underinsured children cannot be considered uninsured for the purpose of obtaining publicly funded vaccines. This is considered fraud and abuse of the Utah VFC Program.

<sup>iii</sup> School entry requirements are those vaccines required upon entry into a Utah school (kindergarten through grade 12; public, private, or parochial) or an early childhood program (ie: preschool, day care center, child care facility, or Head Start Program) for the first time. The child must have no other method to pay for required vaccines and will be excluded from school. **State supplied vaccines are to be used only as a last resort after all other funding avenues have been assessed. Providers must contact the Utah VFC Program for approval prior to administration.**
